Riondel Water Users Close to Achieving Compliance with **Stage 2 Water Conservation Measures**

The RDCK recognizes Riondel water users in their efforts to follow current water conservation measures. This is a reminder of the specific Stage 2 Water Conservation Measures that remain in effect for the Riondel Water System. The current low water levels in the reservoir in conjunction with the high levels of demand and above normal temperature levels for this time of year require that Riondel Water System users conserve water.

Stage 2 Water Conservation Measures include:

- Watering of lawns (including new lawns), gardens, trees and shrubs ONLY between the hours of 6 am - 10 am, and 8 pm - 10 pm
- Watering using drip irrigation, a watering can, and or hand held hose, which eliminates over-spray is permitted at any time.

Please refer to the chart on the opposite side of this notice for a complete description of RDCK Water Conservation Measures Stages 1-4.

The RDCK appreciate your ongoing cooperation in adhering to the above water conservation measures. Stage 2 Water Conservation Measures will remain in effect until further notice and stricter water conservation measures may be required if demand increases significantly, hot and dry weather prevails, or the reservoir declines to critically low levels.

^{*}Drip irrigation delivers water to the root zone of the plants where individual emitters use less than 2 gallons per hours (7.6L/hr) at less than 20psi (140Kpa). This does not include soaker hoses or micro sprayers.
