# 6. OLD BUSINESS

**6.1 East Shore – Area A North Public Information Session – RDCK Budget 2025-2029 Report** Chair Panio provided a verbal report on the March 5, 2025 Budget meeting held at the Riondel Community Centre, Activity Room that was well attended with the following notable key points:

- Addressed drainage and water services noting services funds may not be transferred between services.
- Detail of the budget for all services can be found online at the RDCK Website, located on the Homepage under Financial Information, Plans and Statements.
- A question from the Public was asked why Riondel Road properties do not pay into the S209 service that funds the Riondel Community Centre. Chair Panio responded by explaining that the current taxation area was established by Bylaw 117 in 1972.

**DIRECTION TO STAFF:** That staff review the S209 service area.

- RDCK has hired a new Asset Plan Specialist to look into long range asset planning starting in June 2025.
- Riondel residents could consider creating Community Forestry, similar to those found in Creston and Harrop. To be addressed at the next Commission Meeting May 6, 2025.

# **6.2 Riondel Community Association Initiatives**

Chair Panio provided an update on the Riondel Community Association (RCA) initiatives. A group of RCA member cleaned the stage area and the adjoining storage room in preparation for their Spring Fling Dance.

# **6.3 Circle of Friends Initiatives**

Chair Panio provide a report on the Circle of Friends initiatives and issues, including:

- Plans are in process to set up a community garden next to their building.
- They had an extremely high hydro bill resulting from a broken hot waterline which is currently under investigation by RDCK maintenance staff.

### 7 NEW BUSINESS

### 7.1 Tree Pruning

Chair Panio led the Commission in a discussion about pruning trees in the orchard between Russell and Ainsworth Avenues. The Commission will contribute \$400. A further \$200 to be paid through public donations.

### 7.2 Community Service Meeting Update

Chair Panio to provide an update regarding March 17, 2025 meeting with RDCK General Manager of Community Services, Joe Chirico and Administrative Coordinator of Community Services, Jenna Chapman.

- RDCK staff are looking into streamlining the accounting processes for Riondel Commission operations.
- District staff have procured \$50,000 grant to make improvements in the Community Centre playground.
- RDCK staff are negotiating with Columbia Basin Trust regarding renovations to the Riondel Community Centre. Improvements will be incremental to have minimal impact on activities and programs.

### 7.3 Crawford Bay Hall and Parks Board

Chair Panio led the Commission in a discussion of setting up a meeting with Crawford Bay Hall and Parks Board to discuss service areas and their impact on funding.

- Joe Chirico will schedule a meeting with RDCK staff, Riondel Commissioners and Crawford Bay Hall and Parks representatives to take place in Nelson.

# 7.4 Riondel Community Centre Media Lab Usage

The Commission discussed suggestions for the Media Lab, three suggestions were noted:

- The Youth Group coming to view the room.
- There is interest in using the room to do a radio show.

- Commissioner Cranna will contact a local resident with experience in information technology.

# 7.5 Incident of Vandalism at Riondel Community Centre (March 18th)

- The vandalism was reported to the RCMP in Creston. Unfortunately, there was a glitch with the Surveillance Camera system, so no video is available.
- Kootenay Duct Cleaners will be cleaning vents in the Media Lab and Activity room as soon as authorized.
- Chair Panio suggested the Community Centre needs a better video monitoring system.
- General Manager Joe Chirico advised that any video surveillance has to be set up by RDCK IT Services.
- The Riondel Commission will request that IT Services contact the Commission to review options for providing increased video security.

# 7.6 Process for Selecting New Commission Member

Chair Panio advised that we have two people interested in volunteering for the Commissioner Positions but only one opening. There is a maximum of seven (7) commissioners. The Riondel Commission By-Laws state that the Director and members should look at all applications and make recommendations to the RDCK Board of Directors.

Interested volunteers are requested to submit a letter with information regarding background and experience for review by the Riondel Commission.

### 7.7 Street Sweeping

The Street Sweeping has begun and workers are cleaning up excess gravel for safe removal. Thanks to Yellowhead Road and Bridge (YRB) for their service.
