Chair Panio called the meeting to order at 7:00 p.m.

4. RECEIPT OF MINUTES

The December 6, 2022 Riondel Commission of Management minutes, have been received.

5. DELEGATE

5.1 Draft S241 Water Utility-Area A (Riondel) 2023 to 2027 Financial Plan

Jason McDiarmid, Utility Services Manager, and Alex Divlakovski, Water Operations Manager, provided the Commission with a verbal report regarding the draft S241 Water Utility budget, notable items included:

- a 4% increase in the parcel tax and a 5% increase in water rates for 2023,
- an increase in salaries on account of monthly visits by a Level 2 Operator,
- Benefits increased to \$9274 due to our Maintenance Assistant moving into a full-time, fully benefitted position
- A redesign of the reservoir valve chamber and meter is planned for 2023, and construction planned for 2024
- Intake repairs will be completed in 2023
- Site preparation for the Portable generator scheduled for 2023, possible purchase and install in 2024 based on further investigation
- Contributions to reserves are on the rise
- In long-term planning, consider either replacing the current reservoir or acquiring a second smaller reservoir to increase reservoir capacity.

5.2 Draft S165 Drainage-Area A (Riondel) 2023 to 2027 Financial Plan

Jason McDiarmid, Utility Services Manager, provided the Commission with a verbal report regarding the draft S165 Drainage budget, notable items included:

- increased rates over the 5 years are compensating for historical under-contributions to the service and will provide the funding to do needed work,
- annual rate increases are the maximum allowed under bylaw, another 25% in 2025 is allowed without public approval,
- upgrading the asset management plan and identifying current issues is needed before repairs can be started,
- Director Jackman recommends to have Yellowhead Road & Bridge identify in writing which 18 culverts they own and are responsible for before a consultant is hired for asset management planning.

- Chair Panio expressed concern over the high proportion of the current Drainage budget (over 50%) that has been going to cover administrative expenses for this service.

5.3 Proposed Drainage Bylaw No. 2870 Status

Jason McDiarmid, Utility Services Manager, provided the Commission with a verbal report regarding the status of the proposed drainage bylaw no. 2870, including that it is in its second reading by the Water Services committee and is on hold until there is a memorandum of understanding with Ministry of Transportation and Infrastructure.

6. PUBLIC TIME

No public comment.

7. OLD BUSINESS

7.1 Riondel Community Centre Roof Tender

Chair Panio provided the Commission with a verbal update regarding the Riondel Community Centre roof tender, including that no bids were received by the tender deadline, and that the architect will redraft the tender proposal to address the risk and uncertainty associated with the patch or repair portion of the tender.

7.2 Electronic Notice Board

Chair Panio provided the Commission with a verbal update regarding the electronic notice board, including that he has not talked with maintenance staff about the status of the sign.

7.3 Waste Management

Chair Panio provided the Commission with a verbal update regarding waste management activities in the community, including that there are staffing shortages and bags of garbage have been left behind when no attendant is present. Chair Panio has drafted a public memo regarding the misuse of the Tip-it bins to be posted upon review and approval.

7.4 Surveillance Update

Chair Panio provided the Commission with a verbal update regarding surveillance options for the Riondel Community Centre, including that two Bluetooth cameras have been purchased to install at the community centre.

7.5 Skating Rink Update

Chair Panio provided the Commission with a verbal update regarding the activities at the skating rink, including that the skating rink was well taken care of by community members and residents were happy to have the amenity. A couple of "Use at Your Own Risk" notices have been posted, and further exemplars of notices requested from the RDCK office.

7.6 Snow Ploughing Update

Chair Panio provided the Commission with a verbal update regarding snow removal in the community, including that the tractor has been repaired and a contract for the ploughing of the Bluebell Manor and the Riondel Fire Hall has been given to Akokli Contracting.

8. NEW BUSINESS

8.1 New Thermostat for Auditorium

Chair Panio provided the Commission with a verbal report regarding the thermostat in the auditorium, including that a fully programmable thermostat has been purchased for the auditorium to better moderate the heat.

8.2 Community Planning Discussion

Director Jackman provided the Commission with a verbal report regarding the process for community planning and zoning, including that staff are finding it hard to review every community plan within the Regional District of Central Kootenay every 5 years. Ymir has a simple community plan and could be used as a template for the community of Riondel.

8.3 Curling Club Electrical Subsidy

Chair Panio provided the Commission with a verbal report regarding a request from the Curling Club, including that the Curling club has struggled last 3 years and have requested the Commission to provide financial assistance for the electrical bill that is approximately \$6,000 annually.

Hi Ross,

I've put a further discussion of the motion to support the Riondel Curling Club on the agenda for Tuesday night's meeting. Two or three representatives of the club will do a presentation at the meeting, at the top of the agenda. When those representatives have left, the Commissioners will review the pros and cons.

At the moment, I'm comfortable with our motion to support the club. There are several reasons.

First, we've provided that support in the past. A few years ago, when there was a major breakdown in the ice-making equipment, I recall something like \$15,000 of our budget being used to help the club get back on its feet. This was done at the initiative of RDCK management, and was not carried through as a Commission motion.

Second, the number of options for socializing in the winter season in Riondel is severely restricted at the moment. The only hot meals available here are through the TAPS program, every second Tuesday or so. Our local restaurant has been closed since December, and is still closed. Curling Club volunteers are now providing a \$10 meal once a week on Saturdays, open to everyone. The closure of the pub & restaurant also means that the only social venues in town are Ro's coffee shop, which was closed for all of January, the Community Centre, and the curling club. Not a lot of choices for getting out and meeting people.

Third, the curling club is run by volunteers, similar to the Cable Society. I have a healthy respect for volunteer-run organizations, and believe in helping people who help themselves. The club has dealt with roof repairs and upgrades, taking these responsibilities off the shoulders of RDCK staff and the Commission. This year, the club will be repairing the roof over the lounge--a significant expense even with volunteer labor.

Four, the club is open to everyone, and currently has several teams and a pool of spares. It is the largest single recreational activity in this community during the winter.

Five, the Curling Club has been actively seeking grants to support their activities and building maintenance. Our contribution would take some of the pressure off the club financially, but is only one element in a wider funding strategy.

If you have further thoughts to add to this discussion, I'm happy to include them in Tuesday's discussion if you're still out at the Coast and can't attend the meeting in person or via our phone link.

I'm also happy to follow up on your letter of concern because protocol would have been better followed by having a notice of motion the month before we voted on the Curling Club request. This month's presentation and discussion will hopefully correct that error.

- club membership is open to anyone.
- our Saturday lunch fund raiser has been advertised and is open to the Riondel Community.
- our grant writer makes applications to several organizations every year. A list of these can be made available.
- one of our club members has created a hockey pool for several years to help subsidize our financial needs.
- the club provides pancake breakfasts for Riondel Days in support of this event and as a means to fundraise.
- this past year we have substantially increased our membership fees.
- during the past Covid years, coupled with mechanical failures, our members have continued to pay yearly membership fees, even though the curling season has been shortened or canceled.
- two times per year the curling club holds a fundraising spaghetti supper.
- all maintenance and operating procedures are supplied by volunteers.
- the curling club lounge is available as a venue for local gatherings.
- the curling club building, similar to the Community Centre is in need of new roofing and basic upgrades.
- grant applications have been made to address these issues.
- the curling club encourages and is open to youth and school groups who desire to learn to curl.
- we presently have 32 full time members and 8 spare members.
- this spring we will be replacing and upgrade if the electrical supply to the building, approximately \$20,000.

Hi Garry,

Given the attached letter from Ross Shears, and your comments about sourcing of funding, I think referring this item to February would be appropriate.

In the meantime, the motion stands on record as formally moved, discussed, and carried.

I continue to fully support the motion as it stands, but want a full discussion on the public record so that everyone is clear on why we're taking this step and its impact on the budget

We would also be able to offer Curling Club members a chance to present their request at the next Commission meeting, and solicit further support from community members.

The issue of alternate funding sources could also be addressed..

This is the first time I've seen Ross's letter, so I don't know if it was sent to the Commission as well as to you.

Nor do I believe there's anything "exclusive" about the Curling Club. The exact opposite, in fact.

Also unmentioned is the level of volunteerism involved, the fact that the Commission has contributed substantial amounts of money to Curling Club repairs in the past, and the considerable money that the Club is contributing from its own reserve. I don't believe that the \$3K commitment would necessitate either a tax increase or reduction of the reserve. It could be absorbed in the budget, barring a serious unexpected event such as the sinkhole. The Curling Club provides the single largest recreational & social activity in the Riondel community. I will forward your email to the other Commissioners for further response and discussion.

With respect to the notation in the January minutes of the Curling clubs request for financial assistance and its recommendation to the board :

This being recorded as being directed towards their electrical power bill (just one of many ongoing annual expenses incurred by the club I would suspect) . So to avoid saddling the small community with a direct cost towards a somewhat exclusive , membership only association , the club should plan ahead and write grant requests to the various broad based community funding agencies like possibly Rec #9 and/or Columbia Basin Trust as two examples of funding sources available . The club may also have to consider repricing their dues structure and fund raising activities to ensure operating expense coverage but that is their administrative prerogative .

As a Rate payer in the Riondel catchment area I would like to voice my objection to this request for any amount of funding from the town.

- club membership is open to anyone.
- our Saturday lunch fund raiser has been advertised and is open to the Riondel Community.
- our grant writer makes applications to several organizations every year. A list of these can be made available.
- one of our club members has created a hockey pool for several years to help subsidize our financial needs.
- the club provides pancake breakfasts for Riondel Days in support of this event and as a means to fundraise.
- this past year we have substantially increased our membership fees.
- during the past Covid years, coupled with mechanical failures, our members have continued to pay yearly membership fees, even though the curling season has been shortened or canceled.
- two times per year the curling club holds a fundraising spaghetti supper.
- all maintenance and operating procedures are supplied by volunteers.
- the curling club lounge is available as a venue for local gatherings.
- the curling club building, similar to the Community Centre is in need of new roofing and basic upgrades.
- grant applications have been made to address these issues.
- the curling club encourages and is open to youth and school groups who desire to learn to curl.
- we presently have 32 full time members and 8 spare members.
- this spring we will be replacing and upgrade if the electrical supply to the building, approximately \$20,000.

Given the attached letter from Ross Shears, and your comments about sourcing of funding, I think referring this item to February would be appropriate.

In the meantime, the motion stands on record as formally moved, discussed, and carried.

I continue to fully support the motion as it stands, but want a full discussion on the public record so that everyone is clear on why we're taking this step and its impact on the budget

We would also be able to offer Curling Club members a chance to present their request at the next Commission meeting, and solicit further support from community members.

The issue of alternate funding sources could also be addressed..

This is the first time I've seen Ross's letter, so I don't know if it was sent to the Commission as well as to you. Nor do I believe there's anything "exclusive" about the Curling Club. The exact opposite, in fact.

Also unmentioned is the level of volunteerism involved, the fact that the Commission has contributed substantial amounts of money to Curling Club repairs in the past, and the considerable money that the Club is contributing from its own reserve. I don't believe that the \$3K commitment would necessitate either a tax increase or reduction of the reserve. It could be absorbed in the budget, barring a serious unexpected event such as the sinkhole. The Curling Club provides the single largest recreational & social activity in the Riondel community. I will forward your email to the other Commissioners for further response and discussion.

This being recorded as being directed towards their electrical power bill (just one of many ongoing annual expenses incurred by the club I would suspect) . So to avoid saddling the small community with a direct cost towards a somewhat exclusive , membership only association , the club should plan ahead and write grant requests to the various broad based community funding agencies like possibly Rec #9 and/or Columbia Basin Trust as two examples of funding sources available . The club may also have to consider repricing their dues structure and fund raising activities to ensure operating expense coverage but that is their administrative prerogative .
